Brazil has over 6,700 hospitals, of which 70% are private, yet only 25% of the population has access to private healthcare. With 75% of Brazil's population (approximately 150 million people) only having access to the public healthcare system, and to address the increasing prevalence of chronic diseases and a rising demand for better healthcare services, the Brazilian Ministry of Health has prioritized the digitalization of its Unified Health System – a fundamental structure for healthcare in Brazil.¹

ImExHS's CEO Dr German Arango said; “With over 50% of hospitals found in 5 states, and due to Brazil's large land area, the public hospital infrastructure relies on a vast network of small hospitals. These circumstances are well suited for us as we can deliver lower cost, innovative, cloud-based systems which can serve multi-site operators.”
